



**1. Laboratory Technician-01 Post (UR)**

**Essential Qualification:** B.Sc Medical Lab. Technology/BSc. with Diploma in MLT from recognized university/institute /Board

**Desirable qualification:** Candidates with technical experience of working in virology/Microbiology laboratories and having experience of blood sample drawing from patients will be given preference

**Age Limit:** The age limit is upto 30 years (age relaxation will be given as per Govt of India rules)

**Remuneration per months:** Rs. 30,000/- (consolidated)

**Note:** The selection will be done based on the written examination with minimum qualifying marks of 40% followed by interview of top five qualified candidates.

**Essential Qualification:-** i) Graduation in any discipline from recognized university.


ii) Should possess a speed of not less than 8000 key depressions per hour for data entry work.

## TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. If any declaration given or information furnished by him/her proves false or if he/she is found to have willfully suppressed any material or information, he/she will be liable for removal from service and also such other action as the Government may deem necessary. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he / she does not fulfil essential eligibility criteria.
2. **Tenure:** The assignments are purely on contract basis for an initial period of three months which may be extended upto **31<sup>st</sup> March 2025** in case of satisfactory performance. These appointments will be made from the staff strength sanctioned to **NOHPPCZ under NCDC, New Delhi** and the appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in PGIMER/NCDC/GOI or continued contractual appointment.
3. **Expiry of Contract:** The contract will automatically expire on completion upto 31<sup>st</sup> March 2025 **further renewal is subjected to the sanction from the funding agency** or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
4. **Leave:** The leave entitlement of the appointee shall be governed in terms of the funding agency leave policy as amended from time to time.
5. **Accommodation:** No hostel or any other accommodation will be provided by the institute.


16. Age relaxation for women/SC/ST/OBC non-Creamy/ persons with disabilities (PWD) will be given as per rules.
